Mission of the Social Responsibility Committee

Requests are reviewed quarterly by the Donations Committee, which makes recommendations to the President/CEO for approval on projects that align with DeWaard and Bode's goals to benefit our community.

Donation Guidelines

- 1) All organizations must complete DeWaard and Bode's Request for Donation Form.
- 2) DeWaard and Bode will only consider requests from:
 - a) Tax exempt organizations recognized under IRS 501(c)(3) guidelines or by the WA Secretary of State as a non-profit organization
 - b) Local organizations using the funds in Whatcom County
 - c) Requests that conform to our 2021 mission
 - d) Projects that are identified as a strong need in our community
- 3) DeWaard and Bode will not consider requests for:
 - a) Sectarian, individual or religious purposes
 - b) Propagandizing, influencing elections or legislation
 - c) Foundations seeking capital
 - d) Organizations that have already received funding during the current calendar year.
 - e) Organizations or events which could create controversy or friction.
 - f) Pledges to an individual for an event
- 4) Groups are encouraged to request an exact budget amount, or a portion of a larger budget item. DeWaard and Bode donations typically do not exceed \$2,500 per recipient per year.
- 5) For large donation requests, the committee may ask a representative of the organization to make a presentation to the committee.
- 7) DeWaard and Bode donations are typically made directly to a non-profit as opposed to making the donation through a secondary non-profit that is raising funds for local organizations.
